- 6. Earnest money (Bid Security) is to be paid in the form as mentioned in clause No.16 of ITB
- Bidders shall have to pay the tender processing fee as mentioned above through e-payment
- Bidders shall up load scanned copies of all the papers i.e. Earnest Money, Enlistment Certificate, PAN Card, GST No, and other certificates as required in the eligibility criteria, without which the tenders would not be opened & would be rejected.

- .11. Uploaded documents of valid successful bidder will be verified with the original before signing the agreement. The valid successful bidder has to provide the originals to the concerned authority on receipt of such letter, which will be sent though registered post/email.

Bid documents consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the Contractor can be seen on website https://eproc.punjab.gov.in and scanned copies of the required documents and information as per section-2 (formats & annexure) should be attached in the technical bid as prescribed in the SBD.
