6. Earnest money (Bid Security) is to be paid in the form as mentioned in clause No.16 of ITB.
7. Bidders shall have to pay the tender processing fee as mentioned above through e-payment

8. Bidders shall up load scanned copies of all the papers i.e Earnest Money, Enlistment Certificate, PAN Card, GST No, and other certificates as required in the eligibility criteria, without which the tenders would not be opened & would be rejected.

The original Earnest Money, Enlistment certificate, PAN Card, GST No, and other certificates as required in the eligibility criteria should be deposited with the undersigned before the opening of bid as given in the above table. 11. Uploaded documents of valid successful bidder will be verified with the original before signing the agreement. The valid successful bidder has to provide the originals to the concerned authority on receipt of such letter, which will be sent though registered post/e-mail.
