6. Earnest money (Bid Security) is to be paid in the form as mentioned in clause No.16 of ITB.
7. Bidders shall have to pay the tender processing fee as mentioned above through e-payment only.
8. Bidders shall up load scanned copies of all the papers i.e Earnest Money, Enlistment Certificate, PAN Card, GST No, and other certificates as required in the eligibility criteria, without which the tenders would not be opened & would be rejected.

The original Earnest Money, Enlistment certificate, PAN Card, GST No, and other certificates as required in the eligibility criteria should be deposited with the undersigned before the opening of bid as given in the above table.
