

Whereas, land acquisition proceedings in respect of required land of 15.6250 Acres for the public purpose namely for construction of 200 feet wide sector dividing Road 96/97, 106/107 and 109/110 in the area of villages Bhago Majra and Manak Majra, Tehsil Mohali, District Sahibzada Ajit Singh Nagar were initiated by publishing a preliminary notification under section 4 of the "Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" on 08.03.2021 and the publication of Social Impact Assessment Study was made under Section 6 to be read with 24(1).

Whereas, Department of Housing and Urban Development had notified the section 11 notification and U/s 19 notification on 08.01.2022 and on 06.01.2023 respectively under the above said Act. Accordingly, the announcement of award U/s-26 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" was supposed to be made by 05.01.2024. The extension in the period of announcement of award was granted for two months i.e. 05.03.2024 vide notification 06/05/2021-6Hg1/93 dated: 04.01.2024 but award was not announced even in extended time period on account of administrative reasons.

Therefore, In view of the above, the Governor of Punjab is satisfied that the period of announcement of award needs extension as acquisition of the land is necessitated in the public interest. Thus, in exercise of the powers conferred under U/s 25 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" and all other provisions in this Act enabling him in this behalf, the Governor of Punjab is pleased to notify the further extension in the period of announcement of award of the above scheme from 05.03.2024 to 31.08.2024.
