Whereas, the Master Plan, Dera Bassi was notified under section 70 of the Punjab Regional and Town Planning and Development Act 1995, vide notification no. 8335CTP(Pb)/SD-46 dated 13.11.2009 and amended vide notification no. 6175CTP(Pb)/SD-46 dated 15.12.2016. During implementation of the Master Plan, Dera Bassi, it was brought to the notice of the Government that certain land earmarked as Forest and Open Space in village Bakarpur, Tehsil Dera Bassi, District SAS Nagar, falling in Khasra Nos. 66, 67, 68, 69 and 70, required examination.

Whereas, under Section 65 and Section 77 of 'the Punjab Regional and Town Planning and Development Act 1995', provisions exist for minor modification in the notified Regional Plan and Master Plan respectively; and whereas, with the objective of providing an investment-friendly environment and facilitating economic growth in the State, the Government constituted a committee under the chairmanship of the Director, Town and Country Planning (DTCP) to deliberate upon the necessity of a minor modification in the Master Plan / Regional Plan and to provide recommendations on the basis of various points outlined in the office order dated 03.01.2025, for appropriate decision of the Government.

In view of the above, a 15-day public notice as per the provisions of SOP dated 03.01.2025 was published on dated 15.11.2025 in newspapers. No objections/ suggestions were received during the stipulated period.

Whereas, the matter was deliberated upon by the said Committee under Section 77 of the Act ibid, treating the issue as a cartographic error in the Master Plan. The Committee recommended that the land parcel wherein the cartographic error of Forest and Open Space has been marked be rectified in the Master Plan, Dera Bassi, and that the adjoining land-use zone shall govern such land parcels.

As per above, the approval was granted by the Government vide letter no. H-U-11022/14/2025-4H1/I/1306660/2026 dated 03.02.2026.

Accordingly, the amendment is hereby notified u/s 70(5) of The Punjab Regional and Town Planning and Development Act 1995 as depicted in Drawing No. D.T.P (SAS NAGAR) 2452/2026 dated 09.02.2026.

It shall come into operation from the date of its notification.
