Whereas, Master Plan SAS Nagar was notified vide notification No. 9650 CTP T(Pb)/SC-76 dated 12/16.12.2008 and notification No. 6194 CTP (Pb)/ SC-76 dated 15.12.2016. The Gram Panchayats/ villagers of various villages falling under the Master Plan, S.A.S. Nagar had requested that the certain area of these villages has been kept under the Rural and Agricultural Zone, due to which there is great difficulty in the development of the area of these villages as Residential, Commercial or Industrial activities are not permissible in the Rural and Agricultural Zone. Therefore, it has been requested that the area of these villages be changed from the Rural and Agricultural Zone to Residential Zone in the Master Plan, S.A.S. Nagar.

In view of this request, before making amendments in the Master Plan, S.A.S. Nagar to change the area of villages Bathlana, Saneta and adjoining part of village Raipur Kalan and part of village Darari from Rural and Agricultural Zone into Residential Zone, Mixed use- 1 and Forest and Open Space Zone, the approval for issuing the 30-day public notice as per the provisions of Section 76 of the PRTPD Act, 1995 and as per the decision taken in the 44th meeting of the PRTPD Board dated 04.10.2022, was obtained from the Hon'ble Chief Minister, Punjab-cum-Chairman, Punjab Regional and Town Planning and Development Board.

In the light of the approval received from Government, a 30-day public notice was published on 10.07.2025. A total 56 objections/ suggestions were received during the stipulated period. These objections/suggestions were discussed in the Think Tank Committee meeting held under the Chairmanship of Deputy Commissioner, SAS Nagar on 17.09.2025. All the members agreed to the proposal for amendment of Master Plan, S.A.S. Nagar.

As per above, Master Plan S.A.S. Nagar along with the comments/ recommendations of the Think Tank Committee was placed before 'The Punjab Regional and Town Planning and Development Board u/s 76 of the PRTPD Act, 1995 in its 45th meeting held on 13.01.2026 for amendment in the Master Plan, S.A.S. Nagar to the extent that the area shown under the Rural and Agricultural Zone of above said villages be converted into the Residential Zone, Mixed use- 1 and Forest and Open Space Zone. No approval shall be accorded within the proposed alignment of SAS Nagar - Rajpura railway line.

Accordingly, the amendment is hereby notified u/s 70 (5) of The Punjab Regional and Town Planning and Development Act 1995 as depicted in Drawing No. D.T.P (SAS Nagar) 2449/2026 dated 27.01.2026.

It shall come into operation from the date of its notification.

This issues with the approval of the Government vide letter no H-U-11022/9/2025-4H1/I/1339545/2026/1 dated 10.03.2026 in supersession of the earlier Notification no.: 433 dated: 04.02.2026.
