## NOTIFICATION

Whereas the Governor of Punjab desires that the land is likely to be required at the public expense, in view of the orders of the Hon'ble Punjab and Haryana High Court in CWP 12758 of 2015 and 150036 of 2015 for completion of project in Aero City, Sahibzada Ajit Singh Nagar. Therefore, Missing Khasras of Village Chatt in Aerocity Project as per approved Master Plan vide drawing No. DTP(S) 2280/2016, dated 05.12.2016 revised on 26.02 .2020 \& 04.06.2021 in the area of Village Chatt, Tehsil DeraBassi, District Sahibzada Ajit Singh Nagar are proposed to be acquired.

This notification is made under the provisions of Section-11 The Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013 to all whom it may concern. It is to be noted that in view of the orders of the Hon'ble Punjab and Haryana High Court in CWP 12758 of 2015 and 150036 of 2015 for completion of Project in Aerocity, Sahibzada Ajit Singh Nagar, Social Impact Assessment (SIA) for Compensation for Missing Khasra of Aero City Project, in Village Chatt, Tehsil DeraBassi, District Sahibzada Ajit Singh Nagar is carried out as per Section 4 of the Act ibid. The SIA ascertains that people are not likely to be displaced. There is no major direct impact identified during SIA. The SIA has been disclosed to the people and their representative as per Section 6 of The Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013. Government of Punjab has notified Additional Deputy Commissioner (General) Mohali, as Administrator of the above said project.

In exercise of the powers conferred by the aforesaid section, the Governor of Punjab is pleased to authorize the officers for the time being engaged in the undertaking with their servants and workmen to enter upon and survey the land in the said locality and do all other acts required or permitted by Section 12 of "The Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013".

Any person interested in and having any objection to the acquisition of any land in the said locality may, within sixty days of the publication of this notification, file an objection in writing pertaining to (a) area and suitability of the land proposed to be acquired (b) justification offered for public purpose and (c) the findings of the Social

Impact Assessment report before the Land Acquisition Collector, Urban Development, Ground Floor, PUDA Bhawan, Sector-62, Sahibzada Ajit Singh Nagar.

No person shall without the prior approval of Collector, make any transaction or cause any transaction of land specified in this notification or create any encumbrances on such land from the date of publication of this notification till such times as the proceedings regarding acquisition are completed.

Plan of the land may be inspected in the office of the Land Acquisition Collector, Urban Development, Ground Floor, PUDA Bhawan, Sector-62, Sahibzada Ajit Singh Nagar.
